

Dr. Walker. The proposed amendment is as follows: Article XVIII. Section 1. The right of citizens of the United States to vote shall not be denied or abridged by the Unit ad States or by any State thereof on account of sex. Sec.2. Congress shall have power, by appropriate legislation, to enforce the provisions of this article. Mr. Chairman and gentlemen of the committee, in the first place I hold that Congress has no jurisdiction in this matter. In the next place I am going to show how women have always had equal rights with men, not only since, but before we had the Constitution of the United States. The chairman invited the ladies present to take seats on the bench beside the committee. Dr. Walker. Mr. Chairman, that is chivalry, that is gallantry; but my coming before you is not. I get my rights from the Constitution of the United States, and I am very thankful that this committee has allowed me to speak sooner than they designated, on account of my being a business woman and having engagements, so that I could not be here next month at the time stated. Heretofore before I wrote the Crowning Constitutional Argument it was supposed...
